Petition Packets for City Council Elections Available in the City Clerk's Office

In April 2015, the City of Carbondale will hold an election to select a Mayor and three City Council Members for four-year terms. Information and petition forms are available in the City Clerk's Office.

This election will be for the seats presently held by Acting Mayor Donald Monty, Councilwoman Jane Adams, Councilman Lance Jack, and Councilwoman Corene McDaniel. The seats of City Council Members Lee Fronabarger, Carolin Harvey, and Jessica Bradshaw expire in 2017.

Signed nominating petitions

must be submitted to the City Clerk's Office during the statutory filing period of Monday, November 17, through Monday, November 24, 2014. Candidates should consult the 2015 Candidates Guide available through the Illinois State Board of Elections website at www. elections.il.gov and are strongly advised to obtain legal counsel regarding their qualifications for office and how to correctly circulate, complete and file their petitions.

If five or more candidates file for the Mayoral seat or thirteen or more candidates file for the three City Council positions, a primary election will be held on Tuesday. February 24, 2015. The General Election will be held on April 7, 2015 and the elected Mayor and City Council Members will take office on May 5, 2015.

The City Clerk's Office is located in Room 165 of City Hall, 200 S. Illinois Avenue. Regular office hours are 8:00 a.m. through 5:00 p.m. Monday through Friday. Phone inquiries may be addressed to the City Clerk's Office at 549-5302.

The Carbondale Downtown Master Plan **Advisory Committee - The Journey Begins**

Committee has been holding meetings that will include a broad look at the ideas that the public and members of the committee bring forward to improve the Carbondale downtown. Meetings are scheduled every two weeks, focusing on topics such as transportation, business development, and the interface between SIU/SIH.

The last effort to develop a Downtown Master Plan for Carbondale was completed in 1989. Significant recommendations that were enacted by the City of Carbondale included: City Hall was consolidated and the new Civic Center was built: the Town Square was rehabilitated and the Old Illinois Central Railroad Station was restored; and the City implemented a railroad underpass on Mill Street that has helped alleviate long lines of traffic going east and west.

The Carbondale City Council has directed that extensive public participation be encouraged from the residents, business owners and developers, as well as input from visitors to the City. "We plan to seek participation from all our

Committee Chair. "We have scheduled a series of six or more meetings, up front, and before we engage a consulting firm. This will allow us to develop our own local plan for the consultant to act on. and not the reverse. We don't want an off-the-shelf plan for Downtown". All 18 members of the committee are volunteers who care about Carbondale and are working to generate the best plan for downtown development. 
