## **Video Gaming Terminal Regulations**

No more than five (5) video gaming terminals may be located on the premises. Simulated video gaming devices equipped with a credit reset mechanism or meter are prohibited.

Video Gaming Terminals must be located in an area restricted to persons 21 years of age and over. The entrance to such area must, at all times, be within the view of at least one employee who is at least 21 years of age. A separate area will not be required if the licensed location already restricts admittance to the business to those persons 21 years of age and older.

Video Gaming Terminals may only be operated during the hours when alcohol may legally be consumed.

The applicant for video gaming terminals is responsible for awareness of and adherence to the Illinois Video Gaming Act 240 ILCS 40/1 et seq. in its current form or as amended.

The City Video Gaming Terminal License must be displayed in a prominent area, as must the laminated hotline flier provided with the Video Gaming Terminal license.
