LOCAL LIQUOR CONTROL COMMISSION September 1, 2015

The Local Liquor Control Commission held a meeting on Tuesday, September 1, 2015, in City Council Chambers, Room 108 of the Civic Center, 200 S. Illinois Avenue. Chairman John "Mike" Henry called the meeting to order at 7:00 p.m. with the following-named members of the Commission present/absent:

1. Roll Call

2. Approval of Minutes from July 28, 2015

MOTION: Commissioner Kang moved, Commissioner Grant seconded, to approve the minutes of July 28, 2015. DISCUSSION: None. VOTE: Ayes: C. Harvey, L. Fronabarger, T. Grant, A. Loos, N. Kang, J. Bradshaw, and J. Henry. Nays: None. Motion declared carried.

3. Application for a Class B2 liquor license (On-premises consumption – all alcoholic liquors) from Shaun Kocel, Sole Proprietor, d/b/a Shaun's Place at 201 East Main Street 1B

MOTION: Commissioner Fronabarger moved, Commissioner Loos seconded, to approve the issuance of a Class B2 liquor license to Shaun Kocel d/b/a Shaun's Place at 201 East Main Street 1B, contingent upon receipt of outstanding items. DISCUSSION: The Commission questioned Mr. Kocel about the management of the location in relation to his current employment and the hiring of a manager, the location of the business, and an expected date of opening. 4. Application for a Class A2 liquor license (Restaurant – all alcoholic liquors) from Melba Gastal, Sole Proprietor, d/b/a Sabor de Mel at 606 South Illinois Avenue Suite 2

MOTION: Commissioner Loos moved, Commissioner Fronabarger seconded, to approve the issuance of a Class A2 liquor license to Melba Gastal d/b/a Sabor de Mel at 606 South Illinois Avenue Suite 2, contingent upon receipt of outstanding items and proof of citizenship or resident manager. DISCUSSION: The Commission noted the applicant is not a U.S. citizen and questioned whether and how the license could be issued to a legal permanent resident. City Attorney Kimmel and Melba Gastal responded to the Commission's concerns. VOTE: Ayes: C. Harvey, L. Fronabarger, T. Grant, A. Loos, N. Kang, J. Bradshaw, and J. Henry. Nays: None. Motion declared carried.
