The deadline for entries is **May 25 at 5 p.m.** Entries received after the deadline will **not** be accepted. The Carbondale Halloween Committee will select the winning logo. The design will be unveiled at the June 12 City Council Meeting.

The winner will receive \$150, plus bragging rights for designing Carbondale’s official Halloween logo. The City will acquire ownership of the winning logo and may use the image as it deems appropriate. The City reserves the right not to select a winner, if in its sole discretion, no suitable entries are received.
