The fee for building permits is two dollars (\$2) per thousand dollars of the estimated cost of improvements excluding the costs of the land and the interior chattel furnishings (i.e. the building permit fee for \$50,000 of improvements is \$50,000 X 0.002 = \$100). The minimum building permit fee charge is \$5 for improvements costing \$2,500 or less. A Zoning Certificate must be obtained for new buildings or additions
